Fourteenth resolution	Delegation of authority to the Board of Directors in order to increase the number of shares issued pursuant to the eleventh and twelfth resolutions	Approved (75.82% votes For)
Fifteenth resolution	Delegation of authority to the Board of Directors to increase the share capital through the incorporation of reserves, profits or premiums	Approved (99.82% votes For)
Sixteenth resolution	Authorization given to the Board of Directors to increase the share capital in consideration of contributions in kind within a limit of 10% of the share capital	Approved (90.60% votes For)
Seventeenth resolution	Delegation of authority to the Board of Directors to increase the capital by issue of shares or securities giving access to the share capital of the company, to members of a Company Savings Plan	Approved (82.61% votes For)
